The undersigned warrants the PEBBLE FINA® aggregate products against failure for five (5) years from the date of installation. Upon notification of a failure, Pebble Technology, Inc. ("PTI") shall instruct the Applicator to file reports of verification. Upon receipt of this verification, PTI shall send the Applicator all PEBBLE FINA® aggregate material required to repair the pool finish.

PEBBLE FINA® is a unique pool finish product that has been formulated to combine extreme durability with elegant simplicity.

- PEBBLE FINA® pool finish material (aggregate only) can ONLY be warranted when installed by a Licensed PEBBLE FINA® Pool Finish Applicator.
- The finish is warranted against failure for 5 years--due to material failure, not chemical abuse or structural failure.
- This warranty also excludes damages due to defects in workmanship or physical abuse.
- A requirement for maintaining this warranty is that your pool MUST be REGULARLY maintained per the National Plaster Council Standards for pH, total alkalinity, hardness, cyanuric acid/stabilizer, and total dissolved solids (www.npconline.org).
 - 1) Regular testing and balancing of the pool water should take place at a minimum of once a week. Necessary adjustments must be performed in order to achieve above noted standards.
 - 2) The water chemistry should be maintained according to the "Saturation Index." There are many retail pool stores that provide computer testing to determine your pool water's saturation index. If your pool builder does not provide this service, this type of balancing can be done at a local pool store that offers computerized water testing. For a dealer, check your local Yellow Pages, or contact BioLab at 1-800-998-7946 and choose the "BioGuard" option or check their website @ www.bioguard.com.
 - 3) **If proper water chemistry is not maintained, this limited warranty shall be void.**

THERE ARE NO OTHER WARRANTIES, EXPRESSED OR IMPLIED. THERE IS NO WARRANTY OF MERCHANTABILITY FOR A PARTICULAR PURPOSE.

LIMITATIONS:

1. The Applicator shall have the right to repair the area of failure only, at their option. PEBBLE FINA® material replacement is limited to this repair. It is understood that some cosmetic variation may result.
2. PTI warrants the PEBBLE FINA® aggregate material only and is not responsible for labor to repair said material. Labor warranty will be two years from applicator Sierra Stone & Aggregate.
3. Subsequent costs as to water replacement, chemicals, land and loss of use of the pool are not covered.
4. This warranty shall not include pools that have been abused physically or through lack of proper chemical balancing, chlorine applications or other abuses.
5. Discoloration, staining, marbling, minor surface cracks or checking, spider cracks, shrinkage cracks, cracks, and minor cracks caused by structural damage are excluded from this warranty.
6. Shading, marbling and pigment "swirling" are part of the intended look. These variations are NOT considered a failure.
7. COLOR (if applicable) is warranted for two (2) years only. Fading or lightening is not considered a failure.
8. This is a hand-applied finish and workmanship will fall within industry standards.
9. Warranty is not valid unless a completed gold copy of this warranty and the warranty validation card are returned to PTI (or the warranty validation form may be completed on line at www.pebbletec.com), and the Applicator has been paid.
10. This limited warranty is non-transferable and is only valid to the first buyer listed above.
11. Some pool finishes may contain seashells, such as abalone and mother of pearl. The shells are made up of material from seawater and from a living mollusk. Due to circumstances beyond our control, such as the nature of shell materials and variables of water chemistry, PTI cannot guarantee the lasting integrity of this shell material against degradation and loss of color.
