The undersigned warrants the **PEBBLE TEC/PEBBLE SHEEN** aggregate products against failure for Lifetime from the date of installation. Upon notification of a failure, the Applicator shall file reports of verification. Upon receipt of this verification, Pebble Technology, Inc. (PTI) shall send the Applicator all **PEBBLE TEC/PEBBLE SHEEN** pool finish material required to repair the pool finish.

LIMITATIONS:

1. **PEBBLE TEC/PEBBLE SHEEN** pool finish material (aggregate only) is covered only when installed by a Licensed **PEBBLE TEC/PEBBLE SHEEN** Pool Finish Applicator.
2. Some loss of stone is expected, especially in a new installation; it is not to be considered a failure.
3. It is understood that natural stone and application techniques can result in color variations in tone and appearance. This variation in pool shades is not to be considered a failure. These color and shade variations are one of the highlights of the natural pebble pool finish.
4. The Applicator shall have the right to repair the area of failure only, at their option. **PEBBLE TEC/PEBBLE SHEEN** material replacement is limited to this repair. It is understood that some cosmetic variation may result.
5. PTI warrants the **PEBBLE TEC/PEBBLE SHEEN** material only and is not responsible for labor to repair said material. Labor warranties will vary from state to state and dealer to dealer.
6. Subsequent costs as to water replacement, chemicals, land and loss of use of the pool are not covered.
7. This warranty shall not include pools that have been abused physically or through lack of proper chemical balancing, chlorine applications or other abuses.
8. Minor surface checking, cracks and minor cracks caused by structural damage are excluded from this warranty.
9. The pool water must be tested monthly by a reputable company who uses a computer system. The printed report of the pool water analysis should be kept for future reference.
10. This limited warranty is non-transferable and is only valid to the first buyer listed above.
11. Warranty is not valid until the Applicator has been paid in full.
12. Some pool finishes may contain **seashells**, such as abalone and mother of pearl. The shells are made up of material from seawater and from a living mollusk. Due to circumstances beyond our control, such as the nature of shell materials and variables of water chemistry, PTI **cannot guarantee** the lasting integrity of this **shell material** against degradation and loss of color.
